Bidding is open to all eligible Bidders from all countries as defined in [GON].
2. The [MOCTCA] invites [electronic only] bids from eligible bidders for the procurement of [Stationary /IT Accessories & Printing miscellaneous Items for MOCTCA for Fiscal Year 2078] under National competitive bidding procedures specified in Public Procurement Act and Regulations.

Bidder who chooses to submit their bid **electronically** may purchase the hard copy of the bidding documents as mentioned above[e-bid], may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. 5. Electronic bids must be submitted to the office [moctca] through PPMO's e-GP system www.bolpatra.gov.np/egp on before [18-08-2021:12:00]. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at [18-08-2021:2:00PM] at the office of [moctca]. Bids must be valid for a period of [120days min] from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 105000, which shall be valid for 30 days beyond the validity period of the bid (i.e.120+30 days from the date of bid opening date min)
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
