The Singhadubbar Vaidyakhana Vikash Samiti, Anamnagar, Kathmandu has *allocated* from GoN towards the cost for purchase of Raw materials for production of Medicine and intends to apply part of the funds to cover eligible payments under the Contract for *Procurement of Raw Materials( Jadibuti, Khaneej, Masala, Jantab, Tel and other drabyas)*. Bidding is open to all eligible Bidders as defined in ITB Clause 4 (Eligible Bidders).

The Singhadubbar Vaidyakhana Vikash Samiti, Anamnagar, Kathmandu, Ph no: 014770660 invites *sealed* bids from eligible bidders for the procurement of Raw Materials (Jadibuti, Khaneej, Masala, Jantab, Tel and other drabyas) under National competitive bidding – Single Stage Two Envelope procedures.
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

7. Sealed bids must be submitted to the Singhadubbar Baidhyakhana Vikash Samiti, Anamnagar, Kathmandu by hand/courier on or before 12.00 Noon on 2083/06/06. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM on 2083/06/06 at the office of Singhadubbar Vaidyakhana Vikash Samiti, Anamnagar, Kathmandu. Bids must be valid for a period of 120 days from the bid submission deadline and must be accompanied by a bid security of minimum of NPR. 30,00,000.00 which shall be valid for 30 days beyond the validity period of the bid (i.e 2083-11-06)
