

The Chinese government has established several scholarship programs to support young and outstanding law enforcement officers to study in China. Here is the introduction to the 2026 program "Chinese Government Scholarship Program for International Law Enforcement Students for Bachelor's Degree". You are cordially invited to participate in the program.

I. Program Organizers

Chinese Government Scholarship Program for International Law Enforcement Students for Bachelor's Degree will be organized by relating Police Academy.

II. Candidate Qualifications

1. For Bachelor's Program, candidates should not be older than 30 years old with a senior high school diploma.
2. Candidates should be in good physical and mental health without any infectious diseases or other diseases that may affect learning and training, such as cholera, rabies, malaria, AIDS, cardiopathy and cancer.
3. Candidates in positions concerning law enforcement cooperation with China will be preferred.
4. Candidates should have basic English communication skills.

For health considerations, please do not nominate female candidates who would give birth in China, or are pregnant or breastfeeding, neither nominate candidates who can not put up with high level physical training. Candidates who fail to meet the above-mentioned qualifications will not be admitted or will be expelled from school.

III. Application Procedures

1. The competent department nominates 1 eligible candidates.

2. Candidates should visit <https://www.lecamps.org.cn> or <http://59.252.102.84/f> for downloading the application form, and should print the application form and sign.

3. The competent department provides to the Chinese Embassy (Consulate) the following documents: i) **official letter issued by the department where the applicant works**; ii) **nomination form** issued by the department; iii) **original application form of the applicant**; and iv) **copy of the applicant's private passport ID page**.

4. Since each program has a quota, **it is not guaranteed that all applicants will be enrolled**. MPS will review application documents and arrange phone interviews if necessary. Admissions will be merit-based. Successful candidates will be notified to apply for the Chinese government scholarship online as per requirements.

5. Program organizers authorized by MPS issue offers, Visa Application for Study in China and Foreigner Physical Examination Form to successful candidates. Candidates submit the documents to the Chinese Embassy (Consulate) to apply for X1 visa.

All application form must be submitted on or before **July 15, 2026**. Application form submitted beyond this date will no longer be processed.

IV. Program Duration

The Bachelor's Program will last 5 years. International students will spend one year

learning Chinese in designated university, and on passing the examination, receive full time education for Bachelor's degree in organized institutions for another 4 years. Courses will be given in Chinese.

V. Curriculum Design

The Bachelor's Program's curriculum includes Chinese, Transnational Crime, International Police Cooperation, Practice on Drug Enforcement and policing internship. On finishing all courses and passing all exams, students will be granted a Graduation Certificate by the program organizer and, if meeting criterion for degree awarding, to confer an official bachelor degree.

VI. Costs

The Chinese government will grant each successful candidate scholarship that covers tuition fees, living allowance, accommodation and so on, as well as one round-trip ticket. Here, one round-trip ticket refers specifically to the ticket for the candidate's initial entry into China in the first semester of the first academic year, and the candidate's repatriation flight upon completion of the program and receipt of the graduation certificate. Candidate should bear all other flight costs.

Expenses not included in the scholarship during stay in China will be borne by candidates themselves.

VII. Insurance

Successful candidates shall get a comprehensive medical insurance upon registration. In case of medical treatment or personal accident, candidates shall go to the insurance company themselves to claim compensation in accordance with the insurance contract. MPS and program organizers will provide certain assistance if necessary, but do not bear

any legal obligations. Costs that cannot be compensated according to the insurance contract shall be borne by the candidates themselves.

VIII. Air Ticket to China for the first time

MPS will book international tickets to China (Economy Class) for successful candidates based on the information on the application form and passport. Candidate shall provide the following information accurately:

1. Name of the departure international airport of the home country;

2. Scanned copy of the private passport's ID page;

Self-booked air tickets will not be reimbursed; costs incurred from missing flights due to personal reasons shall be borne by candidates themselves.

IX. Other Issues

1. The application form shall be completed truthfully. In case of any found unconformity between the candidate's actual situation and the information on the application form, MPS reserves the right to reject or withdraw the scholarship. All consequences and related costs shall be borne by the responsible candidate.

2. The time and location of registration will be specified in the Letter of Admission. Program organizers will arrange staff to pick up candidates at the airport. In case of delay or change of flight, please inform Chinese program organizers in time.

3. Candidates shall bring their own police uniforms and suits to China.

4. Candidates dropping out of the program due to personal reasons should not return to the home country until they get an approval and official letter issued to MPS from the candidates' competent department, and should get the approval from MPS too, the air ticket back to their home country under such circumstance will not be covered by China.

5. During learning in China, candidates should abide by Chinese laws and regulations, and the disciplines and rules of the program organizers. Otherwise, candidates shall bear corresponding responsibilities. In cases of serious violations, MPS reserves the right to cancel all scholarship, and such consequences and costs shall be borne by candidates themselves.
