2. The Aayurdeda Chikitsalaya, Naradevi invites **Hardcopy** bids from eligible bidders for the procurement of **Jadibuti Kharid** under National competitive bidding – Single Stage Single Envelope procedures.

5. Sealed or electronic bids must be submitted to the office Aayurdeda Chikitsalaya, Naradevi by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **5:pm** on **2026-09-17**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2083-06-07** at the office of *Aayurdeda Chikitsalaya, Naradevi*. Bids must be valid for a period of **90 Days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NPR **159000/-**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2083/09/06**)
7. If the last date of purchasing and /or submission falls on a public holiday³ applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of the **bid** and bid security shall remain the same as specified for the original last date of bid submission.
