(STF) Bangalamukhi, Kathmandu invites sealed bids from Nepalese eligible bidders for the Construction of Barrack, Retaining wall, Septic Tank, Soak Pit and other Civil Works under National Competitive Bidding procedures. The estimated amount for the works is **NRs. 1,75,97,347/20.**

4. Pre-bid meeting shall be held at Armed Police Force Nepal Headquarters No. 19 Btn. (STF) Bangalamukhi, Kathmandu at **13:00 hrs., 18th September, 2026.**
5. Sealed bids must be submitted to the office Armed Police Force Nepal Headquarters No. 19 Btn. (STF) Bangalamukhi, Kathmandu by hand before 12:00 hrs., on 30th September, 2026. Bids received after this deadline will be rejected,
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs. on 30th September, 2026** at the office of Armed Police Force Nepal Headquarters No. 19 Btn. (STF) Bangalamukhi, Kathmandu. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security, amounting to a minimum of Nrs. 4,75,000/- which shall be valid for 30 days beyond the validity period of the bid (**i.e. 27th January, 2027**).
7. If the last date of purchasing and on falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
