- Sealed Bids must be submitted to **Samridha Terai Madhesh Sinchai Bishesh Karyakram, Jawalakhel, Lalitpur** on or before **12:00 hrs on 2075/12/12**. Documents received after this deadline shall not be accepted. Bids received by the above mentioned deadline shall be opened physically in the presence of Bidders' representatives who choose to attend at the address above at 14:00 Hours on **2075/12/12**.
- Bids must be valid for a period of 90 days and counting from the day of bid opening and must be accompanied by bid security of amount mentioned above, from "A" class Commercial Bank which shall be valid for minimum 30 days beyond the bid validity period.
