1. The Armed Police Force, Nepal Headquarters, Procurement Division invites sealed bids from eligible bidders for the procurement of below mentioned Goods under National competitive bidding Single Stage Two Envelope procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one envelope as per the provision of ITB 23 of the Bidding Document.

5. Pre-bid meeting shall be held at Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu, Nepal at 13:00 hrs., 07th Ashwin 2083.
6. Sealed bids must be submitted to the office The Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu by hand on or before 12:00 hrs. on, 21st Ashwin 2083. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 21st Ashwin 2083 at the office of Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security, amounting to a minimum below mentioned respective coloum, which shall be valid for 30 days beyond the validity period of the bid. 8. If the last date of purchasing and /or submission falls on a public holiday then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
