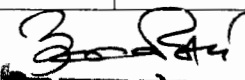

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

5. Pre-bid meeting shall be held at Armed Police Force Nepal Company HQ, Sindhuli at 13:00 hrs., 09th Ashwin, 2083.
6. Sealed bids must be submitted to the office **Armed Police Force Nepal Company HQ, Sindhuli** by hand/courier on before 12:00 hrs., on 22nd Ashwin, 2083. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs. 22nd Ashwin, 2083 at the office of **Armed Police Force Nepal Company HQ Sindhuli**. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security, amounting to a minimum of mentioned, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
