5. Pre-bid meeting shall be held at Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu, Nepal at 13:00 hrs., on 13th Ashwin 2083.
6. Sealed bids must be submitted to the office Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu by hand/courier on or before 12:00 hrs. on, 23rd Ashwin 2083. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hrs on 23rd Ashwin 2083 at the office of Armed Police Force, Nepal Headquarters, Procurement Division, Halchowk, Kathmandu. Bids must be valid for a period of 90 days from the bid submission deadline and must be accompanied by a bid security, amounting to a minimum below mentioned respective coloum, which shall be valid for 30 days beyond the validity period of the bid.
