Details of the courses, terms & conditions of the program and online procedure for applying for these programmes can be seen at the website of the Embassy of India www.indembkathmandu.gov.in under the heading Education/Scholarship in ITEC programme. The last date of receiving nominations is atleast three weeks prior to the start date of the course.
