- 5. Pre-bid meeting shall be held at Department of National ID and Civil Registration Singh Durbar, Kathmandu at 14 Hrs. on 2078-02-07 (21 May 2021).
- Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egp to the above office of Department of National ID and Civil Registration Singh Durbar, Kathmendu on or before 12 Hours on 2078-02-14 (28 May, 2021).
- 7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14 Hrs. on 2078-02-14 (28 May, 2021) at the office of Department of National ID and Civil Registration Singh Durbar, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 2,75,000.00 which shall be valid for minimum 30 days beyond the bid validity period.
- 8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9. The Department of National ID and Civil Registration (DoNIDCR) reserves the right to reject, amend, partly or wholly or cancel the bids without assigning any reasons whatsoever.
