 be rejected.

Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 25,00,000.00 (Twenty Five lakhs only) which shall be valid for 30 days beyond the validity period of the bid (i.e. 10th March 2026)
