1. *The Government of Nepal [GoN], Department of Urban Development and Building Construction has allocated funds from GoN towards the cost of Construction of Access Road to Bancharedada Sanitary Land fill Site (Phase-2)* and intends to apply part of the funds to cover eligible payments under the Contract *for DUDBC-BDSLFSCPIU/WORKS/NCB/02-83/84*. Bidding is open to all eligible as per Section V of bidding document.
2. *Department of Urban Development and Building Construction* invites sealed bids or electronic bids from eligible bidders for the construction of *Access Road to Bancharedada Sanitary Land fill Site (Phase-2)* under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs 3,76,00,000.00*
 - Minimum Work experience of similar size and nature: *minimum one number of project of value 1,00,00,000.00*
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
Or
Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
 4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Department of Urban Development and Building Construction, Babarmahal, Kathmandu, procurementsection@dudbc.gov.np* or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
 5. A complete set of Bidding Documents may be purchased from the office *Department of Urban Development and Building Construction, Babarmahal, Kathmandu* by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of *5000.00* till *2083/06/08 during office hours* in the account as specified below.

6. Pre-bid meeting shall be held at **Department of Urban Development and Building Construction, Babarmahal, Kathmandu** at **2083/05/29 at 13:00 Hrs.**
7. Sealed or electronic bids must be submitted to the office **Department of Urban Development and Building Construction, Babarmahal, Kathmandu** by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00** on **2083/06/08**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2083/06/08, 13:00** at the office of **Department of Urban Development and Building Construction, Babarmahal, Kathmandu**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **6,30,000.00**, which shall be valid for 30 days beyond the validity period of the bid **2083/10/10**.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
