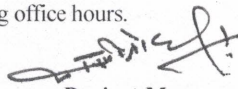

4. Pre-bid meeting shall be held at Project Implementation Unit, Bardagoriya Rural Municipality at **11:00 hrs on 21st August, 2026**
5. Sealed bids must be submitted to the office Water Sector Governance and Infrastructure Support Project, Project Implementation Unit, Bardagoriya Rural Municipality, Muda, Kailali, Sudurpaschim Province, Nepal by hand/courier **on or before 12:00 hrs on 2nd September, 2026**. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on **2nd September, 2026** at the office of Project Implementation Unit, Bardagoriya, Kailali at **14:00 hrs**. Bids must be valid until **31st December, 2026** and must be accompanied by a bid security amounting to a minimum of NRs **3.6 million (Three Million Six Hundred Thousand Nepalese Rupees only)** which shall be valid until **30th January, 2027**.
7. If the last date of purchase and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
