Invitation for Bids

- The Government of Nepal has allocated funds towards the cost of Bheri Babai Diversion Multipurpose Project (BBDMP) and intends to apply part of the funds to cover eligible payments under the Contract for Design, Manufacture, Supply, Transportation, Erection, Testing and Commissioning of Electro Mechanical Works, Contract ID. No.: ICB-EM-01/TGS/BBDMP/2078-079.
- 2. Department of Water Resources and Irrigation (DoWRI), Bheri Babai Diversion Multipurpose Project (BBDMP) invites electronic bids from eligible bidders for the Design, Manufacture, Supply, Transportation, Erection, Testing and Commissioning of Electro Mechanical Works under International Competitive Bidding Single Stage Two Envelope Bidding procedures, Plant and Design-Build.

Bidding is open to all Nepalese and foreign eligible bidders having the following key qualifications:

- (a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: *NRs 1580 Million or 13.3 Million USD*.
- (b) Minimum Bid Capacity: NRs 3,160 Million or 26.5 Million USD.
- (c) Minimum Work experience of similar size and nature:
 - (1) Participation as contractor or subcontractor in at least **one** (1) contracts of Hydropower Project within the last ten years, comprising of Electro Mechanical Works that have been successfully or are substantially completed. The Electro Mechanical Works should be of at least *NRs* 2,530 *Million or* 21.2 *Million USD*.
 - (2) Participation as Contractor or Subcontractor on at least **two (2)** Plant and Design-Build / EPC type Electro Mechanical Works for Hydropower project of minimum 40 MW capacity within the last ten years that have been successfully or are substantially completed. The Electro Mechanical Works should comprise Turbine, Generator and Balance of Plant.
- (d) Works Experience in Key Activities: Experience as Manufacturer of Francis Turbine of minimum capacity 20 MW or Generator of minimum capacity 22 MVA.
- 3. - 4. The bidders shall submit the Bid by visiting PPMO's website www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the non-refundable fee of Bid document NRs. 20,000.00 (In words: Nepalese Rupees Twenty Thousands Only) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. - 5. Pre-bid meeting shall be held at BBDMP, Birendranagar, Surkhet on 13 February, 2022 13: 00 hrs Nepal Standard Time.
- 6. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp. on or before 10 March, 2022 12: 00 hrs Nepal Standard Time.
- 7. Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by scanned copy of bid security in pdf format, amounting to minimum of NRs. 80,000,000 or 680,000 USD (In words Nepalese Rupees Eighty Millions or Six Hundred Eighty Thousands USD) which shall be valid for minimum 30 days beyond the bid validity period. The bid security issued by any foreign Bank outside Nepal must be counter guaranteed by a Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law in Nepal.
- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend on 10 March, 2022 13: 00 hours at the Meeting Hall of Bheri Babai Diversion Multipurpose Project, Birendranagar, Surkhet.
- 9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
- 11. Any additional matters not covered by this invitation shall be in accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation, 2064 (with latest amendment) of the GoN.
