The Government of Nepal has allocated funds towards the cost of Bheri Babai Diversion Multipurpose
Project (BBDMP) and intends to apply part of the funds to cover eligible payments under the Contract
for Design, Manufacture, Supply, Transportation, Erection, Testing and Commissioning of
Hydro-mechanical Works, Contract ID. No.: ICB-HM-01/GPS/BBDMP/2077-078.

Department of Water Resources and Irrigation (DoWRI), Bheri Babai Diversion Multipurpose
Project (BBDMP) invites electronic bids from eligible bidders for the Design, Manufacture, Supply,
Transportation, Erection, Testing and Commissioning of Hydro-mechanical Works under
International Competitive Bidding - Single Stage Two Envelope Bidding procedures, Plant and
Design-Build.

Bidding is open to all Nepalese and Foreign eligible Bidders having the following key qualifications:

(a) Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 1,100 Million or 9.50 Million USD.

(b) Minimum Bid Capacity: NRs 2,200 Million or 19.0 Million USD.

(c) Minimum Work experience of similar size and nature: Participation as contractor or subcontractor in at least two (2) contracts of Hydropower/Water Resources project within the last ten years comprising of hydro mechanical works with gates or penstock pipe, each with a value of at least NRs 1,800 Million or 15.50 Million USD that has been successfully or are substantially completed and that are similar to the proposed works.

4. The bidders shall submit the Bid by visiting PPMO's website www.bolpatra.gov.np. Bidders, submitting their bid electronically, should deposit the non-refundable fee of Bid document NRs. 20,000.00 (In words: Nepalese Rupees Twenty Thousand Only) in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp. on or before 4 May, 2021 12: 00 hrs Nepal Standard Time.

Bids must be valid for a period of 120 days counting from the day of bid opening and must be accompanied by scanned copy of bid security in pdf format, amounting to minimum of NRs. 55,000,000 or 475,000 USD (In words Nepalese Rupees Fifty Five Millions or Four Hundred Seventy Five Thousands USD) which shall be valid for minimum 30 days beyond the bid validity period (i.e., 1 October, 2021). The bid security issued by any foreign Bank outside Nepal must be counter guaranteed by a Commercial Bank or Financial Institution eligible to issue Bank Guarantee as per prevailing Law in Nepal.

The bids will be opened in the presence of Bidders' representatives who choose to attend on 4 May, 2021
 13:00 hrs at the Meeting Hall of Bheri Babai Diversion Multipurpose Project, Birendranagar, Surkhet.

9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.

 Any additional matters not covered by this invitation shall be in accordance with the prevailing Public Procurement Act, 2063 and Public Procurement Regulation, 2064 (with latest amendment) of the GoN.
