1. **Ministry of Education and Sports, Sigha Durbar, kathmandu** has **allocated funds** from **Government of Nepal** towards the cost of **Supply and Delivery of Goods (Stationary and Other Items)** and intends to apply part of the funds to cover eligible payments under the Contract for **MoES/GoN/Goods/083-84/NCB-01**. Bidding is open to all eligible Bidders from all countries as defined in ITB Clause 4 (Eligible Bidders)..
2. The **Ministry of Education and Sports** invites **electronic** bids from eligible bidders for the procurement of **Supply and delivery of Goods (Stationary and other items)** under National competitive bidding – Single Stage Single Envelope procedures.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Ministry of Education and Sports, Singha Durbar, Kathmandu** or may visit PPMO egp system www.bolpatra.gov.np/egp.

Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system (www.bolpatra.gov.np/egp) at no cost

4. Pre-bid meeting shall be held at **Ministry of Education and Sports, Sigha Durbar, kathmandu** at 2 September, 2026²
5. Electronic bids must be submitted to the office **Ministry of Education and Sports, Sigha Durbar, Kathmandu** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hours** on **9 September, 2026**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12:30 Hours on 9 Septemehr, 2026** at the office of **Ministry of Education and Sports, Sigha Durbar, Kathmandu**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NPR 83,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a public holiday³ applicable to purchaser, then the next working day shall be considered as the last date. In such case the validity period of
