5. Electronic bids must through PPMO website www.bolpatra.gov.np on or before above mentioned date and time. Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend on above mentioned date and time at the office of Brahmpuri Rural Municipality and Office of the Municipal Executive, Brahmpuri, Sarlahi, and Madhesh Province, Nepal. Bids must be valid for a period of 90 days after bid opening in case of NCB and must be accompanied by a scanned copy of the bid security in pdf format in case of e-bid, amounting to as mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
