The **Central Jail Hospital (CJH)**, Tripureswor, Kathmandu invites **Sealed Bids** for the Procurement of Goods “**Supply, Delivery, Installation, Testing and Commissioning of Fully Automated 5 Part Hematology Analyzer with Auto Loader and Fully Automated Urine Analyzer at CJH, Tripureshwor, Kathmandu**” under **National Competitive Bidding (NCB) Single Stage Single Envelope** Bidding procedures. Bidding is open to all eligible Bidders from all countries as defined in ITB Clause 4 (Eligible Bidders).

Complete set of Bidding Documents may be purchased from the office of **CJH, Tripureshwor, Kathmandu** during office hours on all working days by eligible bidders from **11 September 2026** onwards on the submission of a **Written Application**, copies of **Firm/Institution Registration & PAN/VAT Registration certificates** and upon payment of a non-refundable fee of **NRs. 3,000** to the Current Account Number: **1000100200010000** maintained at **Rastriya Banijya Bank, Teku**, Office Code: **314023504** and Revenue head: **14229** and original voucher/receipt of the deposited amount must be submitted along with the Application. The Bidding Documents are available for sale till **10 October 2026** during office hours.
3. Interested Bidders are required to submit the Sealed Bids to the office of **CJH, Tripureshwor, Kathmandu** on or before **1:00 P.M. on 2 October 2026**. Bids received after this deadline will not be accepted.
4. Submitted Sealed Bids will be opened in the presence of Bidders' representatives who choose to attend at **1:30 P.M. on 2 October 2026** at the office of **CJH, Tripureshwor, Kathmandu**.
5. Bid must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to minimum of **NRs. 90,000**, which shall be valid for minimum 30 days beyond the validity period of the Bid (i.e. **Valid up to a minimum of 29 January 2027**).
