4. Pre-bid meeting shall be held at **Ministry of Home Affairs, Communication and Law, Madhesh Province, Janakpurdham, Dhanusha at 28 May 2026 on 13:00 hrs.**
5. Electronic bids must be submitted to the office **Ministry of Home Affairs, Communication and Law Madhesh Province, Janakpurdham, Dhanusha** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hrs on 09 June 2026**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hrs 09 June 2026** at the office of **Ministry of Home Affairs, Communication and Law Madhesh Province, Janakpurdham, Dhanusha, Nepal**. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security





in pdf format in case of e-bid, amounting to a minimum of **NRs. 275000.00** which shall be valid for 30 days beyond the validity period of the bid i.e. **07 Oct. 2026**.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the **bid and** bid security shall remain the same as specified for the original last date of bid submission.
