1. The Department of Health Services invites electronic bids from eligible bidders for the Procurement of Consumables for Disaster Response and Preparedness under National competitive bidding – Single Stage Single Envelope procedures.
2. The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/ cross discounts. Evaluation will be done for each package/lot, with contracts awarded based on the award combination that is of least cost to the Purchaser.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of **Department of Health Services Management Division Teku Kathmandu** or may visit PPMO egp system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
4. A complete *set* of Bidding Documents may download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document **NRs. 3,000.00** in the following Rajaswa(revenue) account as specified below.

5. Pre-bid meeting shall be held at **Department of Health Services Management Division Meeting Hall at 22 May 2026, 11:30 Hr.**
6. Electronic bids must be submitted to the office Department of Health Services Management Division Teku Kathmandu through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **13:00 Hr on 4 June 2026** Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:10 Hr. on 4 June 2026** at the office of **Department of Health Services Management Division Teku Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, amounting to a minimum of **NRs. 100,000.00** which shall be valid for 30 days beyond the validity period of the bid (i.e. **2 October 2026**)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
