3. Interested Bidders shall submit the hard copy to Pension Management Office, Tripureshwor, Kathmandu on or before 12:00 hours on 2083/06/20 (6th Oct. 2026).
4. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 hours 2083/06/20 (6th Oct. 2026) at Pension Management Office, Tripureshwor, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 1,19,000.00, which shall be valid for minimum 30 days beyond the bid validity period [i.e.2083/10/20, (3rd Feb 2027)].
5. If bidder wishes to submit the cash security, the cash should be deposited in the name of Ko.Le.Ni.
