The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:0 hrs NST on 2083-06-02 (18th September, 2026)** at the office of **Department of National ID and Civil Registration, Singhadurbar, Kathmandu**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs. 45200/- **NRs. 45,200/-**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **[insert the date]**).
