4. Sealed bids must be submitted to the office **Department of Customs, Tripureshwor, Kathmandu** through PPMO's e-GP system i.e www.bopatra.gov.np/egp on or before **12:00 Hrs on 12th June, 2026**. Bids received after this deadline will be rejected.
5. The sealed bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs 12th June, 2026** at the office of **Department of Customs, Tripureshwor, Kathmandu**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **Nrs 35,000/- (Thirty Five Thousand Rupees Only)**, which shall be valid for 30 days beyond the validity period of the bid (i.e.75 Days). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No: **1700100102030000, District Treasury Control Office, Teku, Kathmandu** at **Rastriya Banijya Bank, Teku, Kathmandu**, and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
