6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 08-06-2026 13:00 at the office of District Hospital Dhankuta  
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 55500 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[2010100202030000] at [Rastriya Banijya Bank Ltd. , Dhankuta Branch] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
