4. Pre-bid meeting shall be held at **Ministry of Land Management Cooperatives and Poverty Alleviation, Sinhadurbar, Kathmandu** at **14:00 Hour, 2nd March, 2020**
5. Sealed bids must be submitted to the office **Ministry of Land Management Cooperatives and Poverty Alleviation, Sinhadurbar, Kathmandu** by hand/courier on or before **12:00 Hour on 12th March, 2020**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hour, 12th March, 2020** at the office of **Sinhadurbar, Kathmandu**. Bids must be valid for a period of **35 days** from the date of bid opening and must be accompanied by a bid security amounting to a minimum of NRs. **125000**, which shall be valid for 30 days beyond the validity period.
7. If the last date of purchasing or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
