

Invitation to present candidates

The Institute for Training and Technical Cooperation is organizing two editions of the WTO Advanced Trade Policy Course (ATPC), in English, during 2026. The ATPCs are level 3 training activities implemented within the WTO progressive learning framework and represent the highest level of learning among WTO training activities.¹ In accordance with the Biennial Technical Assistance and Training Plan for 2026-2027 (WTO/COMTD/W/299), the ATPCs have been redesigned and will be delivered in a blended format comprising four weeks online and four subsequent weeks in-person in Geneva, followed by the development and presentation of an individual action plan. For 2026, a **joint virtual segment** for the two editions of the ATPC will take place from 22 June to 17 July 2026. Two separate in-person segments will take place from 14 September to 9 October 2026 for the first edition of the course, and from 16 November to 11 December 2026 for the second edition of the course.

The purpose of the blended ATPC is to develop participants' autonomy in conducting WTO-related work by: (i) encouraging critical thinking to explore the linkages between WTO rules and disciplines and countries' trade policies and interests in the multilateral trading system; and (ii) enhancing analytical and negotiating skills to engage in trade policy formulation and implementation, monitoring and surveillance, WTO negotiations or dispute settlement. Both legal and economic aspects of WTO rules and disciplines will be examined in a series of interactive

sessions focusing on case studies, simulations, and exercises, including hands-on use of WTO databases and analytical tools available online. Roundtable discussions will provide a platform for practical exchanges, sharing of experiences and best practices as well as debating present-day trade topics. The course also includes attendance at selected meetings of WTO bodies and briefings on WTO work-in-progress. Contacts with WTO Secretariat officials, delegates and representatives from Missions and other international organizations are also a common feature.

The course is targeted at government officials who are directly involved in WTO-related work and who already possess a sound knowledge of the general features of the WTO system and the WTO Agreements. Due to the applied nature of the ATPC, participants are expected to be actively involved throughout the course to further consolidate their knowledge and develop new skills through practice and case-based learning.

Members and Observers to the WTO, which are eligible to benefit from training and technical cooperation activities, are invited to present up to five candidates to participate in this course. Eligible candidates should have completed, preferably within the last five years, a "Level 2" Generalist path WTO training activity² or, in exceptional circumstances, when they have not completed a Level 2 activity, have demonstrably commensurate knowledge or professional experience. They must also possess an excellent ability to communicate in English both orally and in writing.

Two groups of 30 participants (60 in total) will be selected to take part in the two ATPCs. Selected candidates will be assigned to one of the in-person segments based on the availability indicated by the candidate in the application form. Note that all participants need to take part in the mandatory joint virtual segment taking place from 22 June to 17 July 2026. After successful completion of the joint virtual segment, participants will take part in the applicable in-person segment.

The Secretariat of the WTO will make available thirty (30) fellowships for each in-person segment of these two ATPCs. Each fellowship will cover the following: a round-trip airplane ticket in economy class; daily subsistence allowance; a terminal expenses allowance; and accommodation for the duration of the course. **As indicated in the Biennial Technical Assistance and Training Plan 2026-2027, self-funded participation is encouraged when possible, and should be indicated to the Secretariat.**

The attached Application Form must be returned, completed and signed by the candidate as well as by the nominating national authority which presents the candidate, **via the Permanent Mission/Embassy to the WTO, at the latest by 29 MAY 2026.** Selected participants will receive confirmation directly. Additional administrative information, travel details and ticket will be sent shortly after the selection has taken place.

The WTO Secretariat reserves the right to postpone or cancel any of these two activities in the event of force majeure, if sufficient funding cannot be secured in time, or for any other reason that render the execution of the activity impracticable for the organizers.

***Français/Español**

L'Organisation mondiale du commerce organise deux cours avancés de politique commerciale mixtes. Le segment virtuel pour les deux cours aura lieu du 22 juin au 17 juillet 2026 et les segments présentiels auront lieu à Genève du 14 septembre au 9 octobre 2026 pour le premier cours et du 16 novembre au 11 décembre 2026 pour le deuxième cours. Ces cours étant donnés en anglais, l'invitation et le formulaire de candidature sont distribués en anglais uniquement.

La Organización Mundial del Comercio organiza dos cursos avanzados de política comercial en modalidad híbrida. El segmento virtual tendrá lugar del 22 de junio al 17 de julio de 2026 y los segmentos presenciales se desarrollarán en Ginebra, del 14 de septiembre al 9 de octubre de 2026 para el primer curso y del 16 de noviembre al 11 de diciembre de 2026 para el segundo curso. Estos cursos serán impartidos en inglés, por consiguiente, la invitación y el formulario de candidatura serán distribuidos únicamente en inglés.
