The bids will be opened in the presence of Bidders' representatives who choose to attend at **28-May-2026, 13:00 Hour** at the office of *[National Health Education, Inforamtion and Communication Center, Teku, Kathmandu]*. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security amounting to a minimum of NRs. **1,10,000.00** which shall be valid for 30 days beyond the validity period of the bid i.e. **25-September-2026**.
