7. The bids will be opened electronically at **13:00 hours on dated 2083/05/16, (1st Sept, 2026)**, in the presence of Bidders' representatives who choose to attend at **IDO, Surkhet**. Non-attendance of any or all of the bidders' representatives shall not hinder the opening of the Bids.
