4. Pre-bid meeting shall be held at Seti Provincial Hospital, Dhangadhi kailali, at 01:00 PM on 2083/01/17 BS.
5. Only electronic bids must be submitted to the office Seti Provincial Hospital, Dhangadhi kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on 2083/01/30 BS. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 02:00 PM on 2083/01/30 at the office Seti Provincial Hospital, Dhangadhi kailali. Bids must be valid for a period of 90 day from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Bid security mention in table below.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
