5. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00 hours 2083/04/27 (12th August 2026) at **Pension Management Office**, Tripureshwor, Kathmandu. Bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of NRs. 4,80,000.00, which shall be valid for minimum 30 days beyond the bid validity period [i.e.2083/08/24, (10<sup>th</sup> December 2026)].
6. If bidder wishes to submit the cash security, the cash should be deposited in the name of Ko.Le.Ni.
