NOTICE

Malaysia remains one of the primary destination countries for Nepali migrant workers, with an estimated 400,000 Nepali nationals currently residing and working in the country. The Embassy of Nepal in Malaysia has been consistently and systematically authenticating demand letters submitted by Malaysian employers, together with the required supporting documents.

Recently, however, the Embassy has received reports regarding certain **irregular and unauthorised activities**. In view of these concerns, the following notice is issued for the awareness of all concerned:

- Unauthorised and Manipulated Screenshots: Individuals and groups have been taking screenshots claiming that various companies have uploaded documents for demand letter authentication through the online system. These screenshots, some of which are edited, are being circulated among individuals and recruiting agencies in Nepal.
- Misuse and Alteration of Kementerian Dalam Negeri (KDN) Letters: A KDN letter
 issued by the Ministry of Home Affairs of the Government of Malaysia authorising to
 bring in of a certain number of foreign workers is being circulated with many recruiting
 agencies in Nepal with a motive to deceive various parties. Additionally, edited or
 tampered versions of KDN letters have been shared to mislead individuals and
 institutions.
- Unauthorised Access to Employer Accounts: Documents related to demand letter authentication, which must be uploaded solely by the authorised employer, have been found to be submitted through the online system without the employer's knowledge or consent. Such incidents have occurred due to unauthorised access to employers' usernames and passwords.

The Embassy would like to emphasise that all risks, liabilities, and consequences arising from such activities shall rest entirely with the individuals, institutions, or employers involved. All concerned parties are strongly advised not to engage in such unauthorised or fraudulent practices and to remain vigilant to prevent misuse of their documents and online credentials.

The Embassy of Nepal in Kuala Lumpur remains committed to safeguarding the rights and welfare of Nepali nationals working in Malaysia.

- विभिन्न व्यक्ति तथा समूहबाट दूतावासमा विभिन्न कम्पनीको नाममा मागपत्र प्रमाणिकरणका लागि कागजातहरू अनलाइन प्रणालीमा प्रविष्ट गरेको भिन स्क्रिन सट गरी विभिन्न व्यक्ति तथा नेपालस्थित मेनपावर व्यवसायीलाई पठाउने तथा अपलोड गरेको स्क्रिन सटलाई edit गरी पठाउने ।
- मलेसिया सरकारको गृह मन्त्रालय Kementerian Dalam Negeri (KDN) ले जारी गरेको एउटै KDN नम्बर देखाई झुक्याउने तथा KDN नम्बरलाई edit गरी विभिन्न व्यक्ति तथा संस्थालाई पठाई प्रलोभनमा पार्ने ।
- मागपत्र प्रमाणिकरण सम्बन्धी कागजात सम्बन्धित रोजगारदाताले नै अनलाइन प्रणालीमा प्रविष्ट गर्नुपर्नेमा अनलाइन प्रणालीको username र password अनाधिकृत व्यक्तिहरूको पहुचमा पुग्न गई रोजगारदाता कम्पनीको जानकारी वा सहमित वेगर समेत मागपत्रहरू अनलाइन प्रणाली पेश हुने गरेको ।

उल्लेखित गतिविधिबाट पर्नसक्ने जोखिमको जिम्मेवार सम्बन्धित व्यक्ति/संस्था/रोजगारदाता नै हुनेहुँदा त्यस्ता गतिविधिमा संलग्न नहुन र समयमा नै सचेत हुन सम्बन्धित सबैलाई अनुरोध छ।
