7. Electronic bids must be submitted to the office of Krishi Samagri Company Limited (KSCL), Head Office, Kuleshwor through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **13:00 hrs** on May 28, 2026. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 hrs** on May 28, 2026 at the office of Krishi Samagri Company Limited (KSCL), Head Office, Kuleshwor, Kathmandu. Bids must be valid for a period of 120 days from the date of bid opening and must be accompanied by scanned copy of the bid security in pdf format, amounting to a minimum of as mentioned above, which shall be valid for 30 days beyond the validity period of the bid (i.e. October 24, 2026)

The name, identification, and number of contracts (packages/lots) are <i>indicated in BDS</i>.</p> <p>1.2 Throughout this Bidding Document :</p> <ul style="list-style-type: none"> (a) the term “in writing” means communicated in written form with proof of receipt; (b) if the context so requires, singular means plural and vice versa; and (c) “day” means calendar day. |

4.3 A Bidder shall not have a conflict of interest. Any Bidders found to have a conflict of interest shall be disqualified. A Bidder may be considered to be in a conflict of interest with one or more parties in this bidding process if, including but not limited to:

- (a) have controlling shareholders in common;
- (b) receive or have received any direct or indirect subsidy from any of them;
- (c) have the same legal representative for purposes of this Bid;
- (d) have a relationship with each other, directly or through common third parties, that puts them in a position to have access to information about or influence on the Bid of another Bidder, or influence the decisions of the Purchaser regarding this bidding process;
- (e) a Bidder participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which it is involved. However, this does not limit the inclusion of the same subcontractor, not otherwise participating as a Bidder, in more than one bid; or
- (f) a Bidder or any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the goods and services that are the subject of the bid.
- (g) a Bidder that has a close business or family relationship with a professional staff of the Procuring Entity.

4.4 A Bidder that is under a declaration of ineligibility by the GoN/DP in accordance with ITB 3.4, at the date of the deadline for bid submission or thereafter, shall be disqualified. The list of debarred firms is available at the electronic address **specified in the BDS**.

4.5 A GoN-owned enterprise may also participate in the bid if it is legally and financially autonomous, it operates under commercial law, and it is not dependent agency of the Purchaser.

4.6 Bidders shall provide such evidence of their continued eligibility satisfactory to the Purchaser, as the Purchaser shall reasonably request.

नेपाल एउटा कृषि प्रधान देश हो। आय आर्जन र रोजगारीको लागि कृषि एकदमै महत्वपूर्ण क्षेत्र हो र राष्ट्रिय कूल ग्राहस्थ्य उत्पादनको करिब २७ प्रतिशत यस क्षेत्रबाटै उठने गरेको छ। कूल जनसंख्याको करिब ६५ प्रतिशत जनसंख्याको जीवनयापन कृषि तथा यससंग सम्बन्धित क्रियाकलापबाट नै हुने गरेको छ। उच्च गुणस्तरको एवं उन्नत कृषि सामग्रीहरू (मल, विउ विजन, कृषि रसायन र उपकरण) को आयात गरी सर्व सुलभ मूल्यमा किसानहरूलाई उपलब्ध गराउन सार्वजनिक क्षेत्रको संस्था विक्रम सम्बत २०२२ सालमा कृषि सामग्री संस्थानको स्थापना भएको थियो। सुरुमा कृषि सप्लाई संस्थानको रूपमा परिचित यस संस्थालाई पछि खाद्य व्यवस्था समितिमा गाभेर कृषि खरिद विक्री संस्थानको नाम दिईयो दुई वर्षसम्म यस संस्थाले कृषि सामग्री र खाद्यान्न दुवै वस्तुको कारोवार गर्‍यो। पछि विक्रम सम्बत २०३१ सालमा यस संस्थालाई विभाजन गरी कृषि सामग्रीहरूको व्यवस्थापन गर्न कृषि सामग्री संस्थानको स्थापना गरियो। विक्रम सम्बत २०५९ सालमा सरकारले यस संस्थालाई कम्पनी ऐन अन्तरगत नेपाल सरकारको पूर्ण स्वामित्वमा रहने गरी कृषि सामग्री कम्पनी लिमिटेडको रूपमा कार्य गर्दै आई रहेकोछ। कृषि सामग्री कम्पनी लिमिटेडलाई रासायनिक मल खरिद गरी राष्ट्रभर विक्री वितरण गर्ने जिम्मेवारी दिईएकोछ। अन्तराष्ट्रिय बोलपत्रको माध्यमबाट खरिद भएको रासायनिक मलहरू विराटनगर, वीरगञ्ज र भैरहवामा रहेको यस कम्पनीको गोदामसम्म आउने र सो स्थानबाट विभिन्न जिल्लाहरूमा ढुवानी गरी सर्व सुलभ गर्नु पर्ने भएकोले ढुवानीको सेवा प्राप्त गर्न यो बोलपत्र आव्हान गरिएको छ।

34.3 Termination for Convenience

- (a) The Purchaser, by written Notice sent to the Supplier, may terminate the Contract, in whole or in part, at any time for its convenience. The Notice of termination shall specify that termination is for the Purchaser's convenience, the extent to which performance of the Supplier under the Contract is terminated, and the date upon which such termination becomes effective.
