**Ambassador of Nepal Calls on the Permanent Secretary for Foreign Affairs of Thailand**

His Excellency Mr. Dhan Bahadur Oli, Ambassador of Nepal to the Kingdom of Thailand, called on Her Excellency Mrs. Eksiri Pintaruchi, Permanent Secretary for Foreign Affairs of the Kingdom of Thailand, on 05 November 2025.

At the outset, His Excellency the Ambassador conveyed his deepest condolences on the passing away of the Queen Mother of the Kingdom of Thailand.

During the meeting, he shared with the Permanent Secretary that the current situation in Nepal has come to normal and tourism, trade, and other day-to-day businesses have resumed in its regular operations.

His Excellency Ambassador highlighted the priorities of the Government of Nepal, including the reconstruction of devastated infrastructure, strengthening of the rule of law, and enhancement of public service delivery. He further underscored the utmost priority of the Government is to hold the general elections as scheduled for 05 March 2026, and also informed that the Election Commission of Nepal has invited international observers for observation of the election.

The Ambassador expressed his appreciation to the Government of the Kingdom of Thailand for its valuable support in facilitating the safe repatriation of Nepali nationals rescued from various locations in Myanmar, Cambodia, and Laos through Thai territory. He further expressed hope for continued cooperation of Thailand in combating human trafficking, smuggling, and online scamming issues in which several Nepali nationals have been victimized.

His Excellency the Ambassador and Her Excellency the Permanent Secretary also discussed the ongoing bilateral issues of mutual interest, including effective implementation of various bilateral Agreements signed between Nepal and Thailand. They also discussed the possibility of concluding bilateral agreements on Agricultural Cooperation and expressed their commitments to hold the meeting of the Bilateral Consultation Mechanism (BCM) at the earliest possible in convenient dates for both sides.

The meeting was also attended by Her Excellency Mrs. Urasa Mongkolnavin, Director-General of the Department of South Asian, Middle East and African Affairs, and other senior officials of the Ministry of Foreign Affairs of Thailand and Mr. Moti Bahadur Shrees, Deputy Chief of Mission, of the Embassy was also present during the meeting.
