The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 pm NST, 2083-06-13 (29th September, 2026)** at the office of Department of National ID and Civil Registration, Singhadurbar, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRP 45,200/-**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2083-08-26**). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No. **1960100102030000 at Rastriya Banijya Bank Ltd., Singhadurbar Kathmandu**, and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
