- 4. Pre-bid meeting shall be held at Office of the Chief Minister and Council of Ministers Dhangadhi, Kailali at 2082-08-17 (03 Dec 2025), 13:00 hours.
- Electronic bids must be submitted to the office of the Chief Minister and Council of Ministers Dhangadhi, Kailali through PPMO website www.bolpatra.gov.np/egp on or before 12:00 on 2082/08/23 (09 Dec 2025). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 hours, 2082/08/23 (09 Dec 2025) at the office of the Chief Minister and Council of Ministers Dhangadhi, Kailali. Bids must be valid for a period of 30 after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of given in the table below, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
