**General Power of Attorney**

We, the undersigned, are the legal heirs of Late -----, Nepalese national, and holder of passport no. ----- who expired on ----- due to an accident / natural in the State of Qatar, hereby agreed to appoint:

The Nepalese Ambassador / Chargé d' Affairs a.i., in his/ her capacity as Diplomat at the Embassy of Nepal, Doha, Qatar, to represent and act on our behalf in our capacity referred to above in all cases filed by us or against us in front of all different degrees and types of the courts of law (Courts of First Instance, Appeal, Cassation). He has the right to represent us in front of all Ministries, Governmental or Nongovernmental Authorities, Police Stations, Public Prosecution, Organizations, Establishments, Companies and Individual, to represent and sign on documents and attend courts hearing sessions and pleading and defend us, endorse and remission of debt and receive rights, provide quittance and arbitration and conciliation, to cancel and waive claims and procedures, to deny handwriting, stamps and signatures by forgery or any other ways, to submit evidences and request to appoint and reply and appear in front of the experts, to submit statement and reports by objection or appeal, to receive final judgments and execute them in carrying out court, to receive any amounts decided by the courts and submit memorandum, has the right to pay and receive fees, securities and guarantees and receive any amounts deposited under our names at the court's treasury, banks and the different departments, has the right to submit complaints to the all police stations, public prosecution. He has the right to attend and appear at the Courts of Appeal and Cassation, present reasons and statement of Cassation, generally appoint him in any matter related to this power of attorney. The Nepalese Ambassador / Charge' d' Affairs a.i. has the right to designate others in all or any powers granted hereby.

We, hereby grant him this Power of Attorney.
