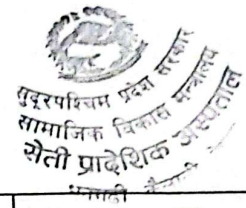
1. The Seti Proviencial Hospital invites *electronic* bids from eligible bidders for the procurement of *Medecine and surgical items for safe motherhood Programme* under National competitive bidding – Single Stage Single Envelope procedures. *The bidder may submit the bid for single or more packages/lots as mentioned below and offer discounts/ cross discounts..*

3. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below .

4. Pre-bid meeting shall be held at *Seti Proviencial Hospital, Dhangadhi kailali*, at 01:00 PM on 2083/09/06 BS.
5. Only electronic bids must be submitted to the office *Seti Proviencial Hospital, Dhangadhi kailali* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 PM** on **2083/09/18 BS**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02:00 PM** on **2083/09/18** at the office *Seti Proviencial Hospital, Dhangadhi kailali*. Bids must be valid for a period of **90 day** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Bid security mention in above table.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
8. The Bid will evaluated on item basis. If the bidder fails to enter into an agreement for the item-wise award based on the bid or package, the entire bid security shall be forfeited."
9. If requested, the bidder must compulsorily submit the minimum unit samples of the specified items of pharmaceutical materials to this hospital within seven (7) days from the date of bid opening. Otherwise, the bid will not be included in the evaluation."
