5. Pre-bid meeting shall be held at Office of the Prime Ministers and Council of Ministers at 4th Magh, 2082 at 12:30 PM.

6. Interested Bidders shall submit electronic bids through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM 20 Magh, 2082).

7. The bids shall be opened in the presence of Bidders' representatives who choose to attend at 14:00 PM 20 Magh, 2082 at the office of the Prime Minister and Council of Ministers, Singhdarbar, Kathmandu. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of ebid, amounting to a minimum of NRs. 3,00,000/- (Three Lakhs), which shall be valid for 30 days beyond the validity period of the bid i.e., 2nd June, 2026 (Jestha 19, 2082)

8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
