- 6. Electronic bids must be submitted to the office of Department of National ID and Civil Registration, Singhadurbar, Kathmandu, Nepal through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hrs (NST) on 12 April, 2021. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 hrs. (NST) on 12 April, 2021 at the office of Department of National ID and Civil Registration, Singhadurbar, Kathmandu, Nepal. Bids must be valid for a period of 120 days from the date of bid opening (i.e., 09 August, 2021) and must be accompanied by a bid security





or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 5, 10,00,000.00 (Nepali Rupees 51 Million) or US\$ 440,000.00 (US Dollar Four Hundred Forty Thousand), which shall be valid for 30 days beyond the validity period of the bid (i.e., 08 September, 2021). The Bid Security issued by foreign Bank must be counter—guaranteed by "A" class Commercial Bank eligible to issue Bank Guarantee as per the prevailing Laws of Nepal.

- 8. All the required documents for bidding process have been mentioned in bid documents. Hence, the Bidders are requested to carefully examine those documents needed for the submission of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 10. The rates quoted shall be clearly mentioned both in figure and in words. In case of non-conformity or ambiguity of the amount in words and in figure, the rates written in words shall prevail. Conditional rates shall not be entertained.
