1. The **Ministry of Health and population, Health Directorate, sapahi, Dhanusha** bids from eligible bidders for The Procurement and Delivery of Ready to Eat Nutrition Food and under National competitive bidding – Single Stage Two Envelope procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Health Directorate, Madhesh Pradesh, Dhanusha, E-mail: phlmc.province2@gmail.com, or may visit PPMO eGP system www.bolpatra.gov.np/egp.
4. A Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at **Health directorate, sapahi, Dhanusha** at **02:00PM, 4th June 2026**
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 noon** on **11th June 2026**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02:00PM on 11th June 2026** at the office of **Health Directorate**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs **2250000** /-, which shall be valid for 30 days beyond the validity period of the bid (i.e. 120 days)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
