1. **Ministry of Education and Culture, Madhesh Province, Education Development Directorate, Janakpurdham** invites **electronic** bids from eligible bidders for **The procurement and Supply of Child Development Educational Learning Materials** under National competitive bidding – Single Stage Two Envelope procedures.
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.

5. Pre-bid meeting shall be organized on **21 May 2026 at 02:00 PM** at Education Development Directorate, Janakpurdham, Dhanusha
6. Electronic bids must be submitted to the office **Education Development Directorate, Janakpurdham** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Noon** on **27 May 2026** Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **02:00 PM on 27 May 2026** at the office of **Education Development Directorate, Janakpurdham**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1000000/-**, which shall be valid for 30 days beyond the validity period of the bid (i.e. **120 days**)
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
