4. *The bids will be opened in the presence of Bidders' representatives who choose to attend at **2082/12/05 on 14:00 PM** at the office of Teachers Service Commission , Sanothimi, Bhaktapur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **NRs 47,000.00 (Forty Seven Thousand only)**, which shall be valid for 30 days beyond the validity period of the bid.
