- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14.00pm on 2082-07-12. at the office of Ministry of Physical Infrastructure and Transport, Singhadurbur, Kathmandu. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rs. 50000, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2082-09-27). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No1960100102030000 at Rastriya Banajya Bank Singadarbur of Treasury Controller Office Singadarbur with Office code no: 337003501 and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
